

Executive Session - Pursuant to Chapter 551, Subchapter D, Texas Government Code, if any.

- C. **Section 551.074. Personnel Matters—**Deliberation concerning the appointment, employment, reassignment, evaluation, duties, discipline, and/or dismissal of personnel.

No action will be taken on matters that are not part of the agenda for the meeting.
