The proposed Vallecillo Road project is a new location roadway that runs east to west, situated about a mile and a half north of Interstate Highway 69 West and aligned with A.F. Muller Boulevard at La Bota Ranch. It will connect FM 1472 (Mines Road) with Interstate Highway 35 and is approximately 2.85 miles long, located within the city limits of the City of Laredo.

Project Need

High traffic volumes of commercial vehicles between the international ports of entry located west of FM 1472 and the developing warehouse districts located throughout northwest Laredo have resulted in increased congestion and travel times on FM 1472. This high traffic volume reduces mobility for both commercial vehicles and the traveling public. With the planned commercial and residential developments in the project area, traffic volumes are anticipated to increase in the future.



Script:

This image gives you an idea of what the Vallecillo Road would look like once constructed. It is designed to be a four-lane facility divided by a concrete raised center median. It has two twelve-foot travel lanes in each direction. Design plans include a four-foot-wide shoulder and a drainage ditch on either side. One side includes a sidewalk, and the other side of the road includes a shared-use path intended for pedestrians and cyclists.

Script:

The Vallecillo Road project is anticipated to be "Open for Bids" by the early part of 2027 and would take approximately one and a half to two years to construct. The project sponsor notifies the construction community that a project is ready to be bid on by publicly advertising for offers from interested and qualified construction contractors.

Construction award of a project typically occurs in three months. Construction on a project begins after the letting and bid process is complete. The total estimated cost for the project is near \$50 million dollars. The project is fully funded.

Script:

The funding for the project is made possible through a public-private partnership. Various entities joined the RMA to bring the project to full funding including the:

- City of Laredo
- Killam Company
- U.S. Department of Housing and Urban Development (HUD) Community Project Funds
- And the Laredo Webb County Area Metropolitan Planning Organization (MPO)

On-going coordination between the RMA, TXDOT and the project partners will continue through the design, environmental review and future phases of the project.

Review and Approval of Environmental Documents

National Environmental Policy Act (NEPA) Assignment to the Texas Department of Transportation

The environmental review, consultation, and other actions required by applicable Federal environmental laws for this project are being, or have been, carried-out by TxDOT pursuant to 23 U.S.C. 327 and a Memorandum of Understanding dated December 9, 2019, and executed by FHWA and TxDOT.

Script:

This project is anticipated to receive federal funds, and because of the federal component, the RMA is required to assess the potential environmental effects of the proposed project in accordance with Federal standards. The process that is followed is called the National Environmental Policy Act process, otherwise known as NEPA, and is overseen by the Texas Department of Transportation (TxDOT) in Texas. The NEPA process provides analyses of the potential impacts to the natural and manmade environment and helps the decision maker to make an informed decision on whether or not to proceed with the project. Under the 2019 Memorandum of Understanding with FHWA, TxDOT assumed NEPA responsibility and serves as the lead federal agency for certain assigned projects.

This review and approval process applies to this project. Environmental studies are being conducted for the proposed Vallecillo Road Project and will be available for review once completed and approved by TxDOT.

Right of Way

- Approximately 74.46 acres of new right-of way is proposed for the project.
- The are no residential displacements.
- There is one (1) non-residential structure displacement.

All right-of-way acquisition would be completed in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.

There will be land acquisition for the right-of-way or ROW used to construct the proposed Vallecillo Road Project.

The following are the significant findings regarding the ROW:

- Approximately 74.46 acres of new right-of way is proposed for the project.
- The are no residential displacements.

All right-of-way acquisition would be completed in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.
